The contract is valid for **1 year**, and it enters into force **7 days** after its signing.



You can get the compensation both in **cash** and in **material form**.**



^{**}Organizing and repairing the damaged property by the insurance company through an organization that has a specific contract with the company.





PROPERTY COVERAGE INCLUDES:



Design and engineering equipment:

- ▶ interior decoration, doors, windows,
- ▶ electricity supply, water supply, heat and gas supply and other systems.



Movable property

- ▶ household u electrical appliances,
- ▶ furniture, clothes, dishes, rugs
- ▶ valuable property, including canvases and other valuables.



Foundations

- ▶ exterior decoration
- ▶ exterior and interior walls.
- ▶ load-bearing partitions, pedestal foundations,
- ⊳ ceiling, roof, balcony.



Liability insurance

▶ damage to the third parties as a consequence of usage, management and/or possession of the property

IN THE EVENT OF AN ACCIDENT!

In case of an accident immediately contact INGO ARMENIA by calling **010 59 21 21**,

Inform the relevant authorities,

Take all the reasonable measures to reduce or prevent further damages.

COMPENSATION SETTLEMENT TERMS

- ▶ The insured is obliged to write an application for insurance compensation within 90 days after the accident and present all the necessary documents,
- ▶ After receiving the documents, the decision is made by the company within 15 working days, after which the compensation is paid within 5 working days.

*For monthly payments, 33% of the total premium should be paid upon the signing of the contract.
